Application sites and methods

Crack & Crevice treatment in areas harbouring or frequented by ants.

Inject nest at 3 to 6 sites in a circular pattern with one site in the centre. Time 5 to 10 seconds per site. Increase injection sites for large nests over 30 cm in diameter. Apply early morning/ late evening hours.

Directly on insects, nests and hiding/ breeding places from approx. 46 cm away. Apply late evening when insects are at rest.

Crack & Crevice or spot treatment.

Inject in cracks and crevices and/or voids where insects may be habouring or hibernating.

Application rates

Amount needed will vary by site, application method and degree of infestation.

Crack and crevice treatment

Spot treatment	1 sec spray on insect
Wall and equipment void	1 to 5 sec spray/0.085 m ³ of calculated void volume
Heavy infestation	Move injector tip at 0.3 m/s
Light infestation	Move injector tip at 0.9 m/s

Directions for general use

Crack and crevice treatment

- 1. Apply using the supplied actuator and injection tubes of system equipment (e.g. System III).
- 2. Place injector tip into cracks, crevices, holes and other small openings where insects may be harbouring, living and breeding.
- 3. Apply at the recommended rate depending on the degree of infestation.
- 4. Several holes may be required in long-running voids.
- 5. Repeat if necessary on 21-day intervals for pests controlled by residual activity.

Spot treatment

- 1. Apply using the supplied actuator and injection tubes of system equipment (e.g. System III).
- 2. Direct nozzle approximately 30 cm from surface being treated, keeping the container upright while spraying.
- 3. Apply directly on insects when possible.
- 4. Repeat as necessary.

Application tips

Can be used as perimeter treatment. For listed crawling insects, apply as a Crack & Crevice or spot treatment where insects may harbour or enter premises.

Individual spot treatments should not exceed 0.19 m² or 20% of the treated surface area, whichever is smaller.

Restrictions

When applying indoors, be sure to vacate areas during application, ensure commercial facilities are not in operation and keep out until surfaces are dry. Maximum of four indoor applications per year.

Do not use in building areas occupied by children or in food service areas except during closed down periods. Food must be covered or removed during treatment.

Do not apply this product in hospital patient rooms while occupied or in any rooms occupied by the elderly or infirm. **Do not** use in patient rooms in hospitals and nursing homes for treatment of bed bugs.

Do not apply to institutions (including libraries, sport facilities, etc.) in the immediate area when occupants are present.

Do not use in aircraft cabins. Only use in aircraft cargo areas.

Do not spray on plastic, painted or varnished surfaces.

Do not spray directly into any electronic equipment (e.g. radios, televisions, computers, etc.).
